It is a measure of the percentage of holdings in a portfolio that differ from those of the benchmark. It is calculated by taking the sum of the absolute value of the differences of the weight of each holding in the portfolio versus the weight of each holding in the benchmark and dividing by two. Where the benchmark is the Russell 2000 Growth, the iShares Russell 2000 Growth ETF is used as a proxy. Where the S&P 500 is the benchmark, the iShares S&P 500 ETF is used as a proxy.

FUND OBJECTIVE & STRATEGY

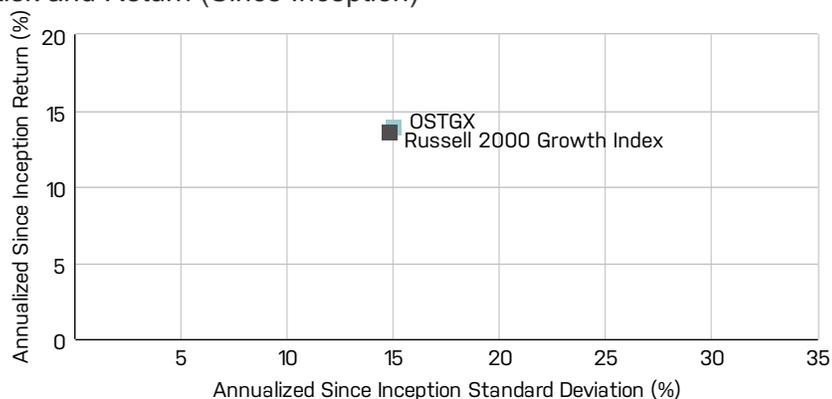
The Fund invests primarily in the common stocks of companies that the the Osterweis Capital Management investment team believes may experience rapid revenue and earnings growth. In selecting investments, the investment team seeks to identify high quality companies within emerging industries and market niches with significant revenue and earnings growth potential before they are widely discovered.

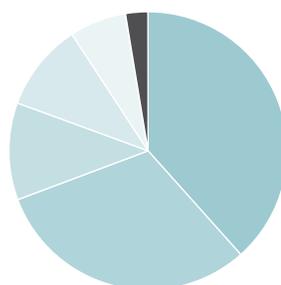
Risk and Return (Since Inception)

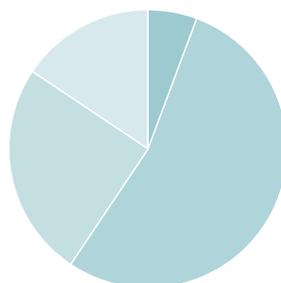
