Dear Shareholder,

During the third quarter of 2017, the Osterweis Strategic Income Fund (the Fund) generated a total return of 1.66%, compared to 0.85% for the Bloomberg Barclays U.S. Aggregate Bond Index (BC Agg). The Fund's annualized total returns over the one year, five year and ten year periods ending September 30, 2017 were 6.74%, 4.93% and 6.28%, respectively, compared to 0.07%, 2.06% and 4.27% for the BC Agg over the same periods.

As discussed in our Investment Outlook, although the markets appear to be plodding along, there are some dynamics within the fixed income market worth further evaluation. Specifically, we think that differences in company ownership within the non-investment grade universe create incentives that may not be well aligned with bondholder interests. Continued diligence in research is required.

Our focus remains on shorter duration, higher yielding bonds based on our belief that economic sensitivity is still preferable to interest rate sensitivity in today's market. In addition to shorter duration bonds, we have added to our convertible holdings and hope to add more when opportunities present themselves. Finally, we are maintaining a meaningful cash cushion to provide us with dry powder when others are selling during market weakness.
